Emissions reduction targets


In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next 3 years to 2 tCO₂e by 2025. This is a reduction of 80%

We intend to implement the following carbon reduction projects

- -Switch to Green Energy This will reduce our baseline carbon emissions by over 80%
- -Carbon Removal of Unavoidable missions We intend to invest in high quality carbon removal projects to remove unavoidable emissions and achieve net zero.
